

SECOND GENERAL MEMBERSHIP MEETING -

MIAMI VALLEY FOLK DANCERS

Date: April 9, 1978

Time and Place: 2:00 P.M. at the United Church of Christ on Edgar Ave.

A general membership meeting was held for the purpose of discussing the building of the north pavilion, and what our club will do in respect to helping pay for the pavilion.

Mr. Malloy, President of the Miami Valley Dance Council, explained the plans for the building. The question was asked as to whether or not it would have a sprung wooden floor; and although Mr. Malloy could not assure us of this, he feels certain it will have. The price of the building will be between \$80,000 - \$100,000. The City of Dayton will provide the land, plumbing, electricity, heating, and maintenance of the building. The Dance Council is asking each person who uses the Michael Solomon Pavilion to donate 25¢ each time the pavilion is used. Once the pavilion is paid for, then the 25¢ fee will be abolished.

Lou Hyll made a motion that we accept the recommended resolution from the MVFD Council, which is as follows:

1. The dues of the MVFD shall be \$2.00 per month effective May 1, 1978 and shall be payable monthly. One dollar of the dues shall be paid to the treasurer of the Miami Valley Dance Council each month after collection.
2. The treasurer shall pay to the MVDC from the MVFD treasury 50¢ per member for the use of the pavilion April 20 and April 27.
3. The paragraph on Fees Per Person in the MVFD Rules and Regulations shall be changed as follows: "Fees Per Person: Associate members, \$1.00; guests, \$1.00; spectators, no charge."
4. Twenty-five cents from fees per person will be forwarded to the Miami Valley Dance Council treasurer each session.

Carolyn Stovall seconded the motion. Discussion followed.

Part 1. Pat Hennessey moved that instead of saying the dues shall be \$2.00 per month effective May 1, 1978, we leave our Rules and Regulations alone and say the dancers shall be assessed \$1.00 per month for the use of the pavilion. Seconded by Frank Hart. Motion was carried.

Part 3. Motion was made by John Pappas to strike out paragraph 3. Seconded by Chas. Castellano. Motion was carried.

Part 4. Sam Ballinger moved that we assess 25¢ per session to associate members and guests. Seconded by Pat Hennessey. Motion was carried.

The original motion as moved by Lou Hyll and amended by the preceding amendments was voted upon and passed. Meeting adjourned at 3:10 P.M.
