Dear President/Leader:

For a long time dancers at Michael Solomon Pavilion have been asking what we can do about improving the ventilation in the summer time.

Recently Mr. Charles Molloy, representing the clubs that dance in the Pavilion, met with representatives of the City of Dayton. The purpose of this meeting was to investigate the possibility of installing exhaust fans in the Pavilion. At this meeting it was agreed that this could be done and that this would improve dancing conditions greatly. It was also agreed that the dance clubs would furnish the fans with related equipment and the City would install them.

Now that we have approval for the installation of the ventilation system, immediate action is required if we are to realize benefits this summer. Also, funds must be made available to purchase the equipment now. To make these funds available, two of the Pavilion dance clubs, the Dayton Square Dance Club and the Two by Fours, have agreed to advance a total of \$2,000.00 for this purpose. The actual cost and amount to be contributed by each of these and all other Pavilion dancing clubs will be determined later. A pro-ratio share will be expected from each.

To establish a planning and management organization for this and future Pavilion support actions and provide the financing necessary to assure their accomplishment, a MICHAEL SOLOMON SUPPORT COMMITTEE is activated as an "ad hoc" committee under the Constitution of the Miami Valley Dance Council. Members of this committee will be the President or Leader of each club regularly scheduled to dance at the Michael Solomon Pavilion and sponsored by the Recreation Dept. of the City of Dayton. (A list of these organizations is attached.)

The Michael Solomon Support Committee will organize with a President, Vice President, Secretary and Treasurer. To provide an interim capability, pending formal meeting and organization, Mady D'Aloiso will act as President and Charles Molloy as Treasurer.

I solicit the support of every club and individual involved in this endeavor in order that we can provide the best possible place for our dancers to dance.
